Workout Rankings: Racingwithbruno system for ranking workouts and tested it at the windows. Our rankings rate works on a scale of horses relative to others in their peer group. We don't just look at time, we look at maidens working with maidens versus maidens working with more esteemed company, etc. The rankings reliably indicate how a horse has been working in relation to its peers at a particular facility. FONT COLOR="RED">THE RACINGWITHBRUNO BULLET WORK is the two-year-old that is outworking his peers by time. We match up two-year-olds vs two-year-olds time-wise only at 4f or longer works. As the two-year-olds develop during their season, we tend to use 5f works and longer for our own brand of **Bullet Work**.

DELTA Figures: DELTA, the fourth letter in the Greek Alphabet and the name of our figure that combines four handicapping factors that can lead to a winning performance. Three years in the making, the DELTA Figures are a combination figure that controls for the conditions of today's race. The lower the number the better chance for success in the field.

DELTA Fig Key

DELTA followed by 'd' is computed off dirt race when no turf race is available

DELTA followed by 't' is computed off turf race when no dirt race is available

DELTA in parenthesis, () is computed off a race more than 90 days prior

Jockey-Trainer-Owner Rankings for each individual circuit are NOW available on your Cheat/Delta Sheet. 4 stars - best, 3 - good, 2 - fair to average, 1 - poor

GoRhythm KEY:

GoRhythm is a Racingwithbruno algorithm that takes into account all of our featured handicapping assets. It assigns points and gives top 3 or 4 selections. It's a great quick synopsis of all the handicapping factors we apply.
